

2 CRPA responses illegally withholding required information from Mr.
3 Chapman’s requests while an adversary of Mr. Chapman, Mr. Seth
4 Davidson, illegally received virtually limitless, un-redacted private
5 information regarding Mr. Chapman. As one of countless other
6 examples, in the Summer of 2018, PVEPD detective Sean Crisfield
7 delayed the investigation regarding Mr. Chapman’s online identity
8 theft to such a degree that evidence became unavailable from third
9 parties (Verizon). Det. Crisfield engaged in further misconduct, failing
10 to obtain and or utilize evidence from third parties (e.g., perpetrator’s
11 NextDoor.com login E-mail address) that would have assisted in
12 identifying the perpetrator of identity theft. The Appendix to this filing
13 contains myriad other examples of Mr. Chapman’s formal, written
14 reporting to the City of its systemic selective and non-law enforcement
15 to Mr. Chapman’s actual or potential detriment.

17 These incidents “occurred,” if anywhere, at various locations within the City
18 Hall, including without limitation, in the City’s Police Department, at Mr.
19 Chapman’s home where he dispatched complaints to the City and at the home of
20 Cynthia Dunbar in the City of Palos Verdes Estates.
